Notification of the completion of the review and the inexpediency of continuing special measures for the import into Ukraine of cut fresh roses, regardless of the country of origin and export

## NOTIFICATION

on the completion of the review and the inexpediency of continuing special measures on the import into Ukraine of cut fresh roses, regardless of the country of origin and export

In accordance with the Law of Ukraine "On the Application of Special Measures on Imports into Ukraine" (hereinafter referred to as the Law), the Interdepartmental Commission on International Trade (hereinafter referred to as the Commission) by its decision of 16.04.2021 No. SP-487/2021/4411-03 applied special measures to import Ukraine cut fresh roses, regardless of the country of origin and export, for a period of three years by introducing a special duty in the following amounts:

from the date of application of special measures in the amount of 56%;

after 12 months from the date of application of special measures in the amount of 44.80%;

after 24 months from the date of application of special measures in the amount of 35.84%.

At the request of Ascania-Flora Limited Liability Company (hereinafter referred to as the Applicant), the Commission's decision No. SP-563/2024/441-01 dated 12.04.2024 initiated a review of special measures for the import of cut fresh roses into Ukraine, regardless of the country of origin and export (hereinafter referred to as the revision).

As part of the revision, the study was conducted for the period from 01.01.2020 to 31.12.2023.

According to the Law, the Commission reviewed the report and materials submitted to the Ministry of Economy on the results of the review and, based on the results of the review, found that:

- import volumes have a significant reduction;
- there are no unforeseen circumstances that lead to an increase in imports, but at the same time there are factors of probable threat due to the presence of significant export potential, which can be reoriented to Ukraine;
- there are other factors related to the military aggression of the Russian Federation against Ukraine, hostilities on the territory of Ukraine and the difficulties faced by the domestic industry (changes in logistics, energy instability, imbalance in foreign exchange markets, etc.);
- import prices remain lower than the selling prices of similar goods in the domestic market and lower than the cost of similar goods of the Applicant;
- key financial and economic indicators of the national producer show improvement (profit, profitability, share in the Ukrainian market, volume of investments for the expansion and modernization of production, labor productivity);
- the consequences of the damage caused by previous periods have been partially eliminated and have a further positive trend of adaptation to competitive conditions.

In connection with the above and guided by the provisions of the Law, the Commission adopted a decision dated 20.05.2024 No. SP-564/2024/441-01, according to which:

completed the revision of special measures for the import into Ukraine of goods regardless of the country of origin and export, which has the following description: fresh roses classified according to the Ukrainian Classification of Goods for Foreign Economic Activity under the code 0603 11 00;

decided not to extend the special measures on imports into Ukraine of cut fresh roses, regardless of the country of origin and export, applied by Commission Decision No. SP-487/2021/4411-03 of 16.04.2021.

The Commission's Decision No. SP-564/2024/441-01 dated 20.05.2024 enters into force on the date of publication of this notice.
