Notification on Issuing the Questionnaires Concerning the Anti-Dumping Investigation on POM Copolymer

Interested parties,

On 19 May 2024, the Ministry of Commerce of the People's Republic of China (MOFCOM) issued Notice No. 18 of 2024, deciding to conduct an anti-dumping investigation into imports of POM Copolymer originating in the EU, USA, Taiwan and Japan. According to the *Anti-Dumping Regulation of the People's Republic of China*, the issuance of the questionnaires for this anti-dumping investigation is notified as follows:

- 1. The questionnaires of the case include the "Questionnaire for Exporters or Manufacturers Outside of Mainland China", the "Questionnaire for Domestic Producers", and the "Questionnaire for Domestic Importers". For details of the requirements, submission methods and timeframe, please refer to the corresponding questionnaires.
- 2. Exporters or manufacturers outside of Mainland China should fill in the Questionnaire for Exporters or Manufacturers Outside of Mainland China as required. Domestic producers should fill in the Questionnaire for Domestic Producers, and domestic importers should fill in the Questionnaire for Domestic Importers as required.
- 3. The date of this notice is the date of questionnaire issuance. The interested parties should submit complete and accurate answer of the questionnaires within the specified time as required. In the event of a situation as stipulated in Article 21 of the *Anti-Dumping Regulations of the People's Republic of China*, the investigation authority may make a determination based on the facts already obtained and the best available information.
- 4. The investigation authority issued the questionnaires through the "Trade Remedy Investigation Informatisation Platform" (https://etrb.mofcom.gov.cn) to the registered interested parties. Other interested parties can down load the questionnaires from the website of the Trade Remedy Investigation Bureau of the Ministry of Commerce (http://trb.mofcom.gov.cn) or the China Trade Remedy Information Network (http://www.cacs.gov.cn).
- 5. Interested parties shall submit the electronic version of the questionnaires through the "Trade Remedy Investigation Informatisation Platform" (https://etrb.mofcom.gov.cn), and submit the paper version at the same time according to the requirements of the investigation authority. The contents of the electronic version and the paper version should be the same and the format should be consistent. If the interested parties have any questions during the distribution of this questionnaire or the process of answering the questionnaire, please consult with the case handler.
