PROVISIONAL PROTECTION PREVENTION IN THE IMPORT OF THE FILM THE RELATIONARY DECISION

Scope

Article 1- (1) This Decision on Import Protection Measures dated 10/5/2004 and 2004/7305 No. 2004/7305 and Communiqué on Import Protection Measures published in the Official Gazette dated 8/6/2004 and 25486 dated 3/11/2023 dated 32358 on Import Protection Measures published in the Official Gazette (Communiqué No.: It covers the procedures and principles regarding the provisional protection measure taken within the framework of the investigation opened with 2023/6).

Temporary protection measure

Article 2- (1) In the import of goods specified in the customs tariff statistical position and definition, additional financial obligation of USD 175 per ton for 200 days as a temporary protection measure shall apply.

- (2) Additional financial liability is guaranteed according to the relevant provisions of customs legislation.
- (3) If it is decided to take protection measures as a result of the investigation, the amount attached to the guarantee shall be recorded.
- (4) If the protection measure is determined as a result of the investigation lower than the provisional protection measure, the amount of guarantee for the difference shall be returned to the concerned. If the protection measure is higher than the temporary protection measure, the difference will not be charged.
- (5) If it is decided that there is no need for protection measures as a result of the investigation, the provisional protection measure shall be repealed. In this case, the amount secured by the customs authorities shall be returned to the concerned persons within the provisions of customs legislation regarding the return of the guaranteed taxes.

Tariff quota

- **Article 3-** (1) In Annex 1, the tariff quota has been opened in order to exempt those of the countries and customs regions originating in Annex 2 of the goods specified in Annex 2 from the implementation of temporary protection measures. The amount of tariff quota is determined as a total of 45.665 tons in each period in which additional financial obligation is applied, the scope of tariff quotas originating in the countries and customs zones in Annex-2. However, the tariff quota for goods originating in each country or customs zone shall not exceed 15.522 tons.
- (2) The procedures and principles for the implementation of the tariff quota and tariff quotas shall be determined by the Ministry of Commerce within the scope of the Decision on Quota and Tariff Quota and Tariff Quota in Import, which was put into effect by the Council of Ministers Decree dated 14/4/2010 and numbered 2010/339.

Other legislation

Article 4- (1) Customs Law numbered 4458 dated 27/10/1999 and other relevant customs legislation, customs duty registration, accrual, collection, reimbursement, reimbursement, follow-up and guarantee shall also apply to the registration, accrual, reimbursement, follow-up and guarantee of additional financial obligation to be applied as protection measure.

Article 5- (1) This Decision shall enter into force on the seventh day following the date of publication.

Don't execute

Article 6- (1) The provisions of this Decision shall be carried out by the Minister of Commerce.
